



## VOTER REGISTRATION

### You Can Use This form to:

- Register to vote in Oregon.
- Update your voter registration.
- Change your name or address on your voter registration.
- Choose a political party or change parties.
- Sign petitions (including initiative, referendum, and recall petitions).

### To Register To Vote In Oregon, You Must Be:

- A resident of Oregon.
- A United States citizen.
- At least 18 years old by Election Day.


### How To Register To Vote:

- Use blue or black ink to fill in boxes 1-13 on the form at the left.
- Mail your completed postcard to your county. Addresses are on the backside of this form.
- Your county elections office will mail you a card to let you know that your registration was received.

### Selecting a Political Party (Box #6)

- Some political parties require you to be registered in their party to vote on their candidates at a primary election.

If card is incomplete, it may be rejected.
